MINUTES OF 14th UNION TERRITORY LEVEL BANKERS COMMITTEE REVIEW MEETING FOR DADRA NAGAR HAVELI, DAMAN AND DIU, FOR THE QUARTER ENDED JUNE 2023 HELD ON 18^{TH} SEPTEMBER, 2023.

The 14th UTLBC meeting of Dadra Nagar Haveli, Daman and Diu for the quarter ended June 2023 was held on 18th September, 2023 at Conference hall, Secretariat, Vidhyut Bhawan, Daman. The meeting was Chaired by Shri. Amit Singla (IAS), Advisor to Hon'ble Administrator, DNH & DD, along with Shri Yogesh Kumar Agrawal, General Manager and Convenor UTLBC, Shri Nikhil U. Dessai (IAS), Secretary Transport, DNH &DD, Shri Jatin Goyal, (DANICS) Jt. Secretary Finance, DNH&DD, Shri Arun Gupta, (DANICS) Jt. Secretary Tourism & Urban Devlopment, DNH&DD, Shri S. Krishna Chaitanya, (DANICS) Jt. Secretary Industry & Trade & Commerce, DNH&DD Shri. Shailendra Kumar Singh RM, BOB, Valsad, Shri Bobby Tanwar, DGM, PNB, Shri Neeraj Daporkar, DGM, UCO Bank, Shri Vivek Joshi, DGM, BOM, Shri. Gaurav Kumar, AGM, DDM, NABARD, Shri Varun Yadav, AGM, FIDD, RBI, Shri Chitransh Joshi, Manager, FIDD, RBI, Ahmedabad, Shri. Dewang Desai, GM, Daman & Diu State Co-op Bank, other Bank officials & LDM's. First of all GM & Convenor of UTLBC has welcomed all the dignitary and participants. In his inaugural address, he briefly highlighted the performance of all Bank in UT of DNH & DD during June-2023 quarter and express his concern on poor performance in APY, SUI, SHG, Agri advance, and other social security scheme. Advisor to Hon'ble Administrator of UT of DNH & DD, Shri Amit Singla (I.A.S) has also address the meeting. In his address, he said that improvement required in PM SVANidhi (TAT should be 15 days), more finance to SHG with the help of NRLM, improvement of performance under PMJJBY, PMSBY, APY and Aadhar seeding. He emphasizes on 100% penetration of all Flagship Scheme of Govt. of India in UT. He has suggested to invite all govt. departments head (UT of DNH & DD) related to govt. flagship scheme of UT along with the Collector/DM of all district.

Observation/Instruction of Advisor to Hon'ble Administrator of UT of DNH & DD, Shri Amit Singla [IAS] as under:

- 1. There should be 100% disbursement of all eligible small vendors under PMSVANidhi scheme and TAT should be minimum. He also emphasis on early sanction/disbursement of 2nd & 3rd instalments to all eligible small vendors.
- 2. Banks should give more finance under SHG, PMEGP, PMMY Scheme

3. Banks should increase Agri advance and achieve the target of 18%.

4. Bank should increase Weaker Sec. Adv and achieve 11.50%.

- 6. Bank should achieve 100 % penetration in all flagship scheme in this F.Y 2023-24.

- 7. Early issuance of banking licence for DDSCB from RBI (Action: RBI)

Observation/Instruction of General Manager and Convenor UTLBC, Shri Yogesh Kumar Agrawal as under:

1. All Banks should improve TAT for sanctioning of loan under PMSVANidhi scheme and achieve target of financing the street vendor under PM SVANidhi scheme. All pending applications should be sanctioned and disbursed within 2-3 days.

2. Enrollment under PMJJBY, PMSBY and APY should be 100%. (Action: All Banks)

3. All Banks should increase Agri advance and focus on PMFME scheme.

Advisor sir & GM sir have asked for achievement of 100% Aadhar Seeding in PMJDY a/cs. Coordinated efforts should be made by all banks and agencies to achieve 100% coverage under social security schemes like PMJBY, PMSBY in UT.

APY: The performance of Banks is not up to the mark and serious efforts are required for improvement.

Advisor sir has asked for increase of finance by all Bank under PMMY scheme. He also urge to increase the finance under Stand up India scheme.

<u>PM SVANidhi Scheme</u>: Advisor sir & GM sir have asked that loan applications of street vendors should be attended promptly and all sanctioned applications should be disbursed immediately and minimize rejection level (Action: All Banks)

Deepening of Digital Payment Ecosystem:

All three districts of UT have achieved 100% digitization in respect of at least one banking digital products.

Advisor sir has asked for achievement of target of 18 % in Agri. Advance and 11.50% in Weaker section advance (Action: All Banks)

Agenda No. 6 Progress under Service Area Credit Plan (SACP) 2023-24:

The overall achievement in disbursement under Annual Credit Plan (ACP) 2023-24 up to quarter ended June 2023, for Priority Sectors by all the Banks was 44.30% in respect of targets in number of accounts and 61.94% in respect of targets in amount. The highest percentage achievement in terms of amount was recorded in Other PSA-79.18% followed by MSME-68.30% followed by Agriculture -62.33% and Farm Credit -60.64%,

Agenda No. 7: Bankwise position of Outstanding, NPA, Percentage of NPA to Outstanding at the quarter ended June 2023.

The Gross NPA of banks in UT is 3.50%. Under Priority Sector, it is 4.61% and in Agriculture, it is 5.07% as of June 2023.

Agenda No. 8: Progress under the Central Government sponsored programmes for FY 2023-24, Quarter June 2023:

As per the progress report at the quarter ended June, 2023 against 8 sponsored applications, banks have sanctioned 8 applications, (i.e. 100% achievement.)

Agenda No. 9: Financing under other programmes/schemes: Self Help Groups:

Advisor sir has asked for more financing to SHG with active participation of NRLM department. He also asked for allotting credit linkage targets to banks and branches and LDM's to follow-up and review the same.

Agenda No. 10: Jan Suraksha Scheme and SVAMITVA Scheme:

All banks, LDM's are requested to include all eligible persons under PMJJBY, PMSBY and APY. The revised premium rates should be displayed at the branch.

S.Krishna Chaitnya, (DANICS), Dep. Sec. Industry, DNH & DD has asked for sanction/disbursement of more proposal in PMFME scheme under coverage of CGTMSE. He also advise for presentation of data related to finance under CGTMSE scheme.
